

GLOSSARY:

"**Featured Entertainment**" means the playing of sound recordings & music videos as the main feature of entertainment and includes music for entertainment, product launches, dancing, karaoke singing and entertainment provided by disc jockeys.

"**Non-featured Entertainment**" means the playing of sound recordings or music videos where it is not the main feature of entertainment, e.g. Background piped-in music including Radio/TV broadcasts.

"**Traditional Coffee Shop**" means non air-conditioned commercial premises where its coffee, tea or other beverages are sold at non-premium prices and includes a restaurant that does not cater for wedding or birthday functions within premises.
